REQUIRED DOCUMENTS FOR THE CIVIL CEREMONY:

- Valid Passport of each intended spouse.
- Original Birth Certificate of each intended spouse.
- Affidavit declaring single status.
- Original Divorce Decree (if divorced).
- Original Death Certificate (if widowed).

Two (2) witnesses whom must present a valid form of identification with a picture are required. The hotel will provide two witness in lieu of their absence.

THE ABOVE-MENTIONED DOCUMENTS MUST BE OFFICIALLY TRANSLATED INTO SPANISH BY A NOTARY IN YOUR COUNTRY OF ORIGIN AND APOSTILLE. Documents must be submitted to the Wedding Planner a month prior to the ceremony. Original documents must be presented before the Civil Judge on the day of the wedding.

REQUIRED DOCUMENTS FOR THE RENOVATION OF VOWS:

• Copy of the Marriage Certificate.

IMPORTANT:

- All documents must be originals.
- The couple must check-in into the hotel two (2) days prior to the wedding and all forms and documents must be sent at least one month before their arrival.
